APPLICATIONS and PAYMENTS received or postmarked on or before April 1, 2018.

- **Season Paid** - \$85 if paid before April 1, 2018
- If agreeing to pay for the season, to be eligible for the \$85 rate, vendors must have their full balance paid by April 1, 2017. If there is an unpaid balance after April 1, the vendor will then owe \$15 to participate in the 2018 season.
- Break down is \$4 a week for the 2018 season from May 18th- October 5th (21 weeks)
- Rome Farm Market Vendors will have access to the Hazel Street Farmers Market in Adams WI every Wednesday from May 16 - October 10.
- Art in the Park at Friendship Park- May 19th- \$15 fee if you would like to attend. (Regular cost is \$25)
